#### 3.2 Treasurer's Report (Ray Elder)

Ray submitted his report as at 30<sup>th</sup> June 2018 by email as follows.

I have pleasure in attaching the Financial Statements for the Officer Training Unit Association Inc. ("National") for the year ended 30 June 2018.

#### (1) National Accounts

OTU National financial statement Accounts are for the year ended 30 June 2018.

In the month of June, revenue applicable to the year ended 30 June 2018 consisted only of Q sales of \$150, and interest of \$21.27. However, cash flow was very active with 2018/2019 subscriptions of \$5,500, and leadership donations of \$795 being received.

With regard to expenditure, costs relation to web site maintenance (\$550), and attendances at the funeral of Stan Maizey (together with a contribution towards function costs) (\$1,172.20), had to be met.

#### Revenue

Revenue for the year ended 30 June 2018 totalled \$27,212.41 and, ignoring the one off receipt of the "Scheyville Mess Funds" in 2016/2017, this was \$1,745 above revenue for the previous year. The increase was due to increased annual subscriptions and increased Q sales over the 12 months. Due to the efforts of Membership Officer, Graeme Chester, and various class reunions, it was very pleasing to see that annual subscriptions have not decreased as had been expected, but have increased.

#### **Expenditure**

Expenditure for the year ended 30 June 2018 totalled \$24,811.70 which was \$7,869.63 more than expenditure for the year ended 30 June 2017. This increase was due to abnormal expenditure including:

- Payments to State Chapters to assist in funding Youth Leadership activities (\$5,000).
- The cost of "OTU" pavers at North Head.
- Subscription to the National Vietnam Veterans' Museum, and
- Costs relating to the funeral of Stan Maizey.

Net profit for the year was \$2,400.71, which was well in line with expectations.

#### **Balance Sheet**

As at 30 June 2018, Net Assets of the Association were \$92,724.24, an increase of \$2,400.71 over that figure at 30 June 2017.

The Association has no liabilities other than "OTU Family" liabilities as follows

- Youth Leadership donations (\$1,895) held for subsequent dispersion to the respective State chapters.
- Amounts held by OTU National on behalf of the South Australian State Chapter.
- Subscriptions received, but applicable to periods after 30 June 2018.

In summary, OTU National was in a strong financial position as at 30 June 2018 and remains so. It is noted that a further \$10,000 has been earmarked for allocation to State Chapters over the next two years to assist with the funding of Youth Leadership activities, and funds will also be earmarked towards the funding of what might be a final Nation Reunion within the next three years. Preliminary discussions regarding the reunion have commenced.

The meeting approved the National Financial Statements and adopted the Accounts, as at 30June 2018.

### **OTU ASSOCIATION OF AUSTRALIA**

### **NATIONAL CHAIRMAN'S REPORT 2017-2018**

- 1. Although there has been no specific national event or celebration (such as the 50th anniversary of the commencement of NS in 2015, or the battle of Long Tan in 2016 respectively), the Association has enjoyed a pleasing twelve months. One of the main features has been our reaching the highest number of financial members (499) in well over a decade. This is no doubt due to the increasing interest brought about through the growing number of Class Reunions, as well as more people reaching retirement age and having the time available. Membership Officer, Graeme Chester, has also played a big part with his enthusiastic perseverance. Many thanks Graeme.
- 2. We were saddened by the June passing of former CI, Stan Maizey. Stan made a most positive impression of those who trained under him at OTU. Furthermore, he had, for several years, been a member of the Queensland Chapter of the Association. He was also recently remembered for taking the salute for the "March in Review Order" on the Scheyville parade ground as part of the 2013 reunion. A strong number of Association members attended his funeral.
- 3. Financially, we remain on a very strong footing. In light of the latest projections, per capita general purpose disbursements to the State/Territory Chapters have been increased from \$10.00 to \$20.00 per annum commencing 2018 -19. Furthermore, as a continuation of the granting of funds for Youth Leadership that commenced in 2017, similar amounts will be forwarded to the State/Territory Chapters for this year and the next.
- 4. The National Executive is always open to reasonable requests for funding activities that further the aims and goals as laid down in the Constitution. Thanks go to Treasurer, Ray Elder, for his diligent work over the year.
- 5. Our affiliation with the National Servicemen's Association (NSAA) continued with our Chairman attending that body's two national Council meetings. The first (September '17) was in the ACT and, as per normal, included a wreath laying ceremony recognising the service and sacrifice of National Servicemen. The second (March '18) marked the launch of the NSAA Scholarship Fund to sponsor selected young people to study medicine and related disciplines.
- 6. Consideration is being given towards running a "mini" type National Reunion in the year after next. This is only in its embryonic stage and people will be kept up to date as the concept progresses.
- 7. Members are being encouraged to join the Duntroon Society the body open to all graduates from the Royal Military College, the Portsea Officer Cadet School, the WRAAC Officer Training Unit and the Scheyville OTU. This is of particular interest to those who chose to stay on after the completion of their national service obligation, and to those who continued their service in the Reserve Forces.
- 8. There have been more Class Reunions taking place with many getting together for the first time since graduation. Several have been held to celebrate fifty years since that special day when they marched out of Scheyville.

- 9. The State and Territory chapters have all been active some to a greater extent than others, due to numbers and geographical considerations. Regular luncheons continue as a significant attraction as do dinners, weekends away and golfing occasions.
- 10. The Association's youth development activities have continued. Victoria fully or partly sponsored nineteen young people to the 2018 Lord and Lady Somers Camps. Queensland pursued its VITAE programme, South Australia, Operation Flinders, Western Australia, the Leeuwin Programme, and the ACT, Rotary's RYLA programme.
- 11. Scheyvillians again marched behind the OTU Banner in several states as part of the year's ANZAC Day parade.
- 12. Three more outstanding additions of "The Scheyvillian" were produced. This publication has received great acclaim from the many other service organisations to which it is sent. Its reviews on recent military publications, its "whatever happened to??" articles, and its fifty year recollections of peoples' time at Scheyville make for fascinating reading. Our thanks go to editor, Neil Leckie, for his outstanding work. As archivist and historian Neil is also doing a splendid job.
- 13. The Association's Website and IT efficacy continue to improve thanks to Webmaster, Ian Kelly. His contribution, too, has been much appreciated.
- 14. May I thank Deputy Chairman, Brian Cooper for his help over the year. Similarly, my thanks go to Secretary, Bernie Gleeson, for his first-class contribution. Quartermaster Peter Don has kept good control of the Association's badges and other consumables. Thanks Peter.
- 15. Finally I am indebted to committee members Alan Brimelow, Rob Youl and Robin Hunt for their input and advice over the year.

### Independent Auditor's Report to the members of Officer Training Unit Association (National)

### 1. Report on the Financial Statements

I have audited the accompanying two pages of Financial Statements, being a special purpose financial report, of the Office Training Unit Association (National), which comprises the Balance Sheet as at 30 June 2018 and the Trading Profit and Loss Statement for the year ended 30 June 2018.

### 2. Committee's Responsibility for the Financial Statements

The Committee of the Association is responsible for the preparation and fair presentation of the Financial Statements, and has determined that the accounting policies are appropriate to meet the needs of the members. The Committee's responsibilities also include:

I disclaim any assumption of responsibility for any reliance on this Report or on the Financial Statements to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

Thank you to Frank Miller for his praise on the 'production of another excellent Scheyvillian'. While I do prepare some articles using the information I hold for the association that I believe that the members should know about, the quality of The Scheyvillian depends mainly on the input received from the members. I have used up most of the backlog of articles held-over from previous editions and will be looking at a big input from members between now and the next Edition in December.

#### Memorabilia:

Brian Cooper handed me a beautifully bound set of documents on Class 2/71 Senior and Class 3/71 Junior, from a Class 2/71 Reunion (the disappointing thing was that I already had a set, although there are some differences to the content). He also handed me an Inventory of a Cadets Room: 3 PI, Room 25, from the time of Cadet S. J. Elphick (Class O2/72).

Bernie Gleeson passed on an original copy of a Class 1/69 Graduation Parade Brochure, a photograph of John Sierakowski, and a 'photo-shopped' photograph of The Pope wearing an OTU Badge. I have made enquiries about the source of these photographs.

### **RMC Museum Update:**

The following is an email from Maj David Bucholtz on the current state of the renovations of the RMC Museum, to be known as 'Army Museum Duntroon':

'Further to last edition of the Scheyvillian, I am pleased to report that we are still targeting a December opening (this year!) for the Army Museum Duntroon. Confidence of meeting this deadline has been heightened with the recent appointment and start of a full time professional curator at AMD – Mr Paul Mitrovich. Paul has extensive experience (in his capacity as an ARes member) with the Army History Unit having been Assistant Curator at the Australian Army Infantry Museum (AIMM), Collection Manager for the AIMM and the Army Museum of NSW, A/Manager Army Museum of NSW, Objects Curator for three AAHU-AWM Field History Teams and provided support to Unrecovered War Casualties. Most recently Paul has also spent the last 16 months as a (civilian) researcher with the Anzac Memorial Centenary Project, and continues to work closely with the Australian War Memorial, which he has done for over a decade. Should any of you wish to make contact with Paul please do so by dropping him a note at: paul.mitrovich1@defence.gov.au, so more to come next edition, including photos of the museum which of course will feature OTU along with the other full-time officer training schools.

Further to the above I expect Paul will make contact with the view of tapping in to your own experience and knowledge of OTU and the OTU Association more broadly.

Finally, as part of the main display area refurbishment we have been fortunate to acquire all new high quality museum display cases. So rather than relegate the display case donated by the OTU Association to a back room or hallway we have found it a new prominent location - the reading room of the Officer's Mess Duntroon. Rest assured we will see that the "presented by" plaque remains firmly in place and that the OTU story is presented and preserved in a suitable form.'

### Appendix 5

### WEBMASTER'S REPORT

- 1. The Website provides an area where Scheyvillians can access all relevant information about the Association, including Members lists, details of Events scheduled by States, photo gallery, archives of The Scheyvillian, and minutes of AGMs etc. It also has created a permanent historical database about our unique piece of Australian military history that will eventually, out-live its members.
- 2. One area not mentioned previously is the Feedback Section whereby any person can send an OTU website contact form to the Webmaster with questions and/or information. This financial year we have had 46 such requests.
- 3. Another area that we have focused on this year is The List of Deceased Scheyvillians (thanks Neil Leckie). There are now 182 on the list, with obituaries linked to 103 of them (where an obituary exists, the surname is coloured BLUE).
- 4. On 1 July 2018 an email/newsletter was sent reminding all members (now Unfinancial) that payment was required. The email was sent to 1103 Members by the Website Newsletter/email system, and after removing all invalid email addresses and 'do not contacts', labels were printed containing postal addresses for 135 Unfinancial Members. Graeme Chester mailed envelopes containing the reminder letter on 2 July 2018. As indicated in the Membership Report, the response has been well above expectations. The next step is to retrieve email addresses for the 894 members who now have a "blank" email address instead of invalid emails (as arranged by Nik Dow, the Systems Administrator).
