3.2 Treasurer's Report (Harry Moyle)

Harry Moyle presented his report as at 30th June 2021 as follows;

I am pleased to report that the OTU National entity has survived (financially) during a very difficult year in Melbourne associated with entry and exit from lockdowns due to the COVID-19 pandemic and having a new Treasurer.

The Association should be very grateful to Ray Elder for his 20+ years as Treasurer of OTU National and/or OTU Victoria.

The Executive has continued to meet regularly, both in-person when possible and by Zoom when required by lockdown restrictions.

Our income from member subscriptions (\$31,300) has been maintained at similar levels to the previous year (\$32,150). However, sales from the Q Store have decreased and sales of our very successful Coffee Table Book have decreased by 97% or \$22,401. This latter item was expected.

Total income was down \$6,606 compared to the previous year.

Expenses were down compared to the previous year, principally due to lack of activities associated with Youth Leadership, Q Store purchases/operating costs and Commemoration costs associated with pandemic funeral restrictions. A notable increase in expenses was associated with website maintenance associated with the cost of Zoom meetings.

Total expenses were down \$13,193 or 35% compared to the previous year.

Overall, our activities generated a surplus of \$8,056 for the current year compared to a \$1,469 surplus for the previous year.

The Balance Sheet records Net Assets of \$94,335, up \$8,056 from the end of the previous year.

Our bank deposits are a very healthy \$114,401.

During the second half of the year, your Executive has reviewed and updated the existing financial projections for the next 5 years. Major expenditure for a National Reunion was moved forward to the 2021/22 year and various other projected expenditures were adjusted consistent with our two primary objectives of (a) supporting member fellowship and (b) supporting youth leadership development. Membership subscriptions were maintained at the existing amount of \$50 per annum. Our cash holding at the end of the 5 year term is projected to be \$14,517.

5. GENERAL BUSINESS

- a. Confirmation of Appointment – Auditor Mr Con Sarrou CPA

Following a briefing by the Treasurer Harry Moyle on the credentials and suitability of Mr Sarrou for the position, the Chairman proposed that the meeting confirm the

prior appointment by the National Executive of Mr Sarrou as Auditor to the OTU Association.

The motion was seconded by Bernie Gleeson and agreed by the meeting

b. Constitution Amendment – Honorary Auditor to Auditor

Currently the OTU Association Constitution states that “a suitably qualified person be appointed as Honorary Auditor at the Annual General meeting”, implying that the incumbent is not paid.

The reality of the situation in 2021 is that it is difficult to get someone from with our contacts network to fill the position. This situation, combined with the perception that as a matter of governance the incumbent should be seen to be at arm’s length from the organisation, adds to the need for change. Changing the terminology from Honorary Auditor to Auditor will also provide a level of flexibility in the appointment process.

Consequently the Chairman moved that ‘wherever the term Honorary Auditor appears in the Constitution, the wording be amended to read Auditor’.

The motion was seconded by Harry Moyle and agreed by the meeting

c. Nominal Association Wind-Up - June 2026/Membership Subscriptions

In the period leading up to the AGM, there has been discussion on the nominal Wind Up date for the OTU Association in June 2026, the possible inferences to be drawn from the OTU Association’s detailed Five Year Financial Projection, and in particular how member’s subscriptions may play out over the ensuing period.

It has been apparent to the National Executive that a balance between the requirements of the Constitution in relation to Fellowship and Youth Leadership, how Membership Fees may possibly be adjusted as we get close to the end date, how States/Territory may continue in their own ways after the National entity winds-up, were competing priorities in the wind-up plan. Attendees at the meeting confirmed this approach.

Some possible outcomes included;

- (a) In light of the Five Year Financial Projection Membership could be adjusted to achieve a situation where no fees were payable in the last year, given that there was support for membership fees continuing at this stage, which received significant support, and
- (b) Once again referring to the Financial Projection, after the Constitutional requirements in relation to fund distribution to Fellowship and Youth Leadership had been satisfied, remaining funds may be able to be distributed to the remaining States/Territory on a per capita basis.

Following extensive discussion, and input from State/Territory representatives, the feeling of the meeting was that the National Executive should continue in its deliberations in fleshing out a plan for the Wind-Up, and at an appropriate time distribute to the States/Territory representatives and members the details of the plan, with the intention of receiving support for the proposed course of action.

All positions were declared vacant. Previous incumbent office bearers and members, having advised prior to the meeting they we're happy to continue in their roles, were re-elected.

OTU ASSOCIATION OF AUSTRALIA

NATIONAL CHAIRMAN'S REPORT 2020-2021

The COVID 19 pandemic had a major impact on the year, curtailing so many of the usual Association activities. Most State Chapters, apart from the ACT and Queensland, were unable to participate in their capital city ANZAC Day marches. Nationally, the October reunion was first deferred until 2021 and, due to ongoing concerns over the virus, again until 2022. Many luncheons and dinners did, however, proceed to varying degrees in different locations.

During the year the NSW Parks Department called for tenders for the leasehold of Scheyville National Park - the site of OTU. The Association made submissions to the government seeking assurances that members would still have access to the location and that relevant points of memorabilia would be retained. At the time of writing we are still awaiting a decision.

Much serious consideration is being given to a mechanism for the eventual closure of the Association. A nominal year of 2026 has been identified for this to take effect. Perhaps the most likely cause would be the inability to form a viable committee (a phenomenon noted in other organisations with a similar demographic – Probus being one case in point). Work carried out on this so far includes financial projections, investigations into the retention of OTU's memorabilia and the possible erection of an appropriate commemorative monument or display.

Nationally many of the youth development activities were abandoned due to COVID -19. Victoria's Lord and Lady Somers January camps were both called off.

The National Executive welcomed one of the Association's founders, Alistair Pope, back into its ranks at the start of the year.

Financially the Association remains in a strong position. We thank Harry Moyle for his diligent work over this, his first year, in the role. Under Harry's guidance a new auditor Mr. Con Sarrou CPA, has been appointed. We are grateful for Mr. Sarrou's predecessor, David Burke, for his valued input over the years.

Secretary. Bernie Gleeson is commended for his fine execution of his duties. Special mention is made of his first-class meeting minutes and handling of administrative matters. From a management point of view, significant forums – National Executive, National Council and the AGM - continued successfully through the pandemic by the medium of Zoom. We are most appreciative of the work of Webmaster Ian Kelly who made all this possible. Ian has further streamlined our system making it simpler to use as well as making it more secure.

Despite the COVID -19 limitations membership numbers remained at the same level as 2019/20 - the highest for well over twelve years. Many thanks go to Membership Officer Graeme Chester for this outcome.

Once again, due to the dedication of "The Scheyvillian" editor, Neil Leckie, we have seen another three issues of this excellent publication. Featuring, among other things, military book reviews, reminiscences of Scheyvillians and articles on "whatever happened to" it has rightly become a highly regarded publication in the wider defence circle. Sadly, there is also an increasing number of "vales" on recently passed members. Neil's work on maintaining the Association's memorabilia and his close liaison with the RMC museum for this purpose is also very much appreciated.

Quartermaster Peter Don has again done a great job in sending off different Q Store items as ordered and maintaining stocks at a suitable level. Thanks for your work Peter. I am also most appreciative for the help and advice that Deputy Chairman, Brian Cooper, has given over the year. Similarly, the valued input from Rob Youl, Alistair Pope, Robin Hunt and Alan Brimelow is also warmly acknowledged.

We look forward to the next twelve months with positive expectations and trust we can fully resume celebrating "The Scheyville Experience".

MEMBERSHIP REPORT

At the end of the FY 20/21 at 30th June our financial membership was **650**, the same as at the end of FY 19/20.

We currently have **599** financial members (including Honorary and Widows), which is slightly more than the **583** we had at the 9 September 20 AGM, and just 51 less than the **650** we had at the end of the last FY. With a bit of luck, and another reminder to all unfinancial members in early December, we should get somewhere near the mid 600s by 30 June 22.

There was a lull in renewals in August so reminders were sent out by email to **257** members who had been financial in recent years, but who had not renewed for FY21/22. This resulted in a burst of renewals over the last week or so which brought us up to **599** financial members from the **541** at the August National Executive Meeting meeting.

Since last year's AGM we have had **six** new members come on board and we have recorded **14** more deaths.
