OTU Victoria again enjoyed a successful year financially with the year resulting in a Net Profit of \$2,698.25 and with Net Assets rising from \$25,772.74 at 30 June 2019 to \$28,470.99 as at 30 June 2020.

As at 30 June 2020, OTU Victoria had no liabilities and all assets were represented by money held in the Bank.

Financially, OTU Victoria remains in very healthy financial position as at 30 June 2020.
